# Thank you!

To all families for having ongoing conversations at home about kindness and friendship!

To all parents for supporting our motto: Be Kind, Be Safe, Be Fair, and for reminding students to make positive behaviour choices! The Delta School District already has an administrative procedure in place to cover the use of Personal Communication Devices (Admin Procedure 145) that provides guidance for schools and educators. In the coming months, the district expects to receive more detailed guidelines from the government regarding the restriction of students' cellphone use in schools. Once that information is received, the district will look at making any necessary changes for implementation at the start of the new school year in September.

At Pinewood, our student planner includes our student handbook where we have shared procedures for cell phones and other electronics. This can also be found on the school website. For your reference:

#### **CELL PHONES AND OTHER ELECTRONICS:**

We understand that some students have cell phones for reasons determined by their parents when walking to and from school. However, these **phones MUST BE TURNED OFF once on the school grounds and NOT USED at school** unless being used under direction of the teacher. **Students must go through the school staff for a phone pass**, to use the office phone **if they require assistance.** It is important that the office is kept aware of any emergency need.

• Teachers will be in touch with families if devices are going to be used to support education and learning in the classroom

• Students will bring home a user agreement to be signed and returned to the school.

• When students bring their electronics (iPads, smartphones, etc.) to school without prompting from the staff, they will not be given permission to use the device and are required to keep it in their backpack.

• The school is not responsible for the device's safe keeping.

• We are concerned about the safety and privacy of our students. Smartphone cameras or other recording devices are not to be used around the school without the permission of the classroom teacher and the subjects in the photo.

• Parents will be notified if their child is not following our guidelines on electronic use. Students may be asked to keep their devices at home.

• It is important for parents to closely monitor all their child's online activities.

#### Lockdown Drill

On Thursday, Feb. 15, we will be conducting a Lockdown Drill. During this drill, we will be joined by Vanessa Heal, our District Emergency Preparedness officer, and the Delta Police. Just as we prepare our students to properly respond to a fire drill, they also need to be aware of the proper response during a "lockdown" and "hold and secure". We encourage you to discuss how you expect your child to behave and respond during an emergency or disaster situation.

All schools in the District are required to hold Lockdown and Hold & Secure drills. The purpose of the drills is to provide training for students and staff, so everyone knows what to do in the event of a safety threat.

We realize that the mention of a "lockdown" may raise some questions and concerns. While the incidents of threatening behaviours in our schools is very, very low, we hope that you find this knowledge of our procedures reassuring.

During the Lockdown Drill, an announcement will signal the start. Students and staff will secure in the nearest classroom or office. All classroom doors will be locked and blinds will be closed by supervising adults. Students will be instructed to move out of sight of windows and doors, and will be asked to remain silent. No one will be permitted to leave the room until the drill is over. An announcement will again signal the end of the drill. This will all be complete in about 7 -8 minutes.

Parents and members in our community may notice a police presence in front of our school before, during and after our Lockdown Drill. We partner with the Delta Police in drills like this as they will be taking over and coordinating the response in such a situation. Their practice in navigating our halls and communicating with our staff is vital in their response preparedness as well.

### Drinks at School

At Pinewood, students are encouraged to bring a full water bottle to school each day. The water bottle can be kept with the student at their desk or in an easily accessible location that the classroom teacher has identified. During the lunch eating time, students may drink juice boxes or other such drink choices that parents have chosen to provide. At the end of the eating time, it is expected that these 'other' drinks are finished or put away according

to teacher instructions. Such drinks must be easily resealed. This is to avoid sticky spillage which can damage student work. Additionally, parents are asked to refrain from delivering drinks other than water during the school day.
